

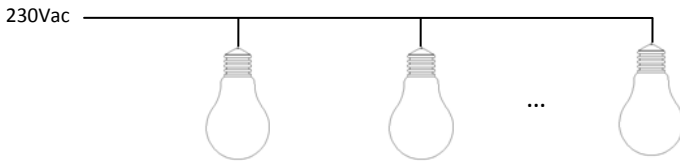
1. Technical details

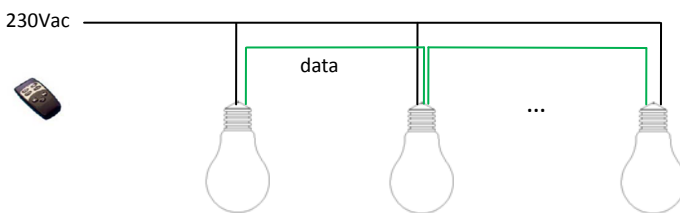
2. Wiring diagram

Always switch off electricity preceding connection
Only to be connected by authorized persons.

Version White : Cable **3x1.5mm²** OR **5x1.5mm²** when DALI or 1-10V dimming.

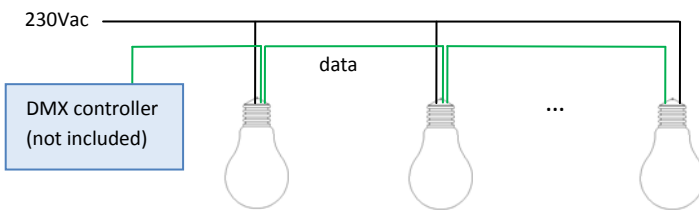


Version **RGB** Remote control

° Cable **DMX or FTP** for RGB data

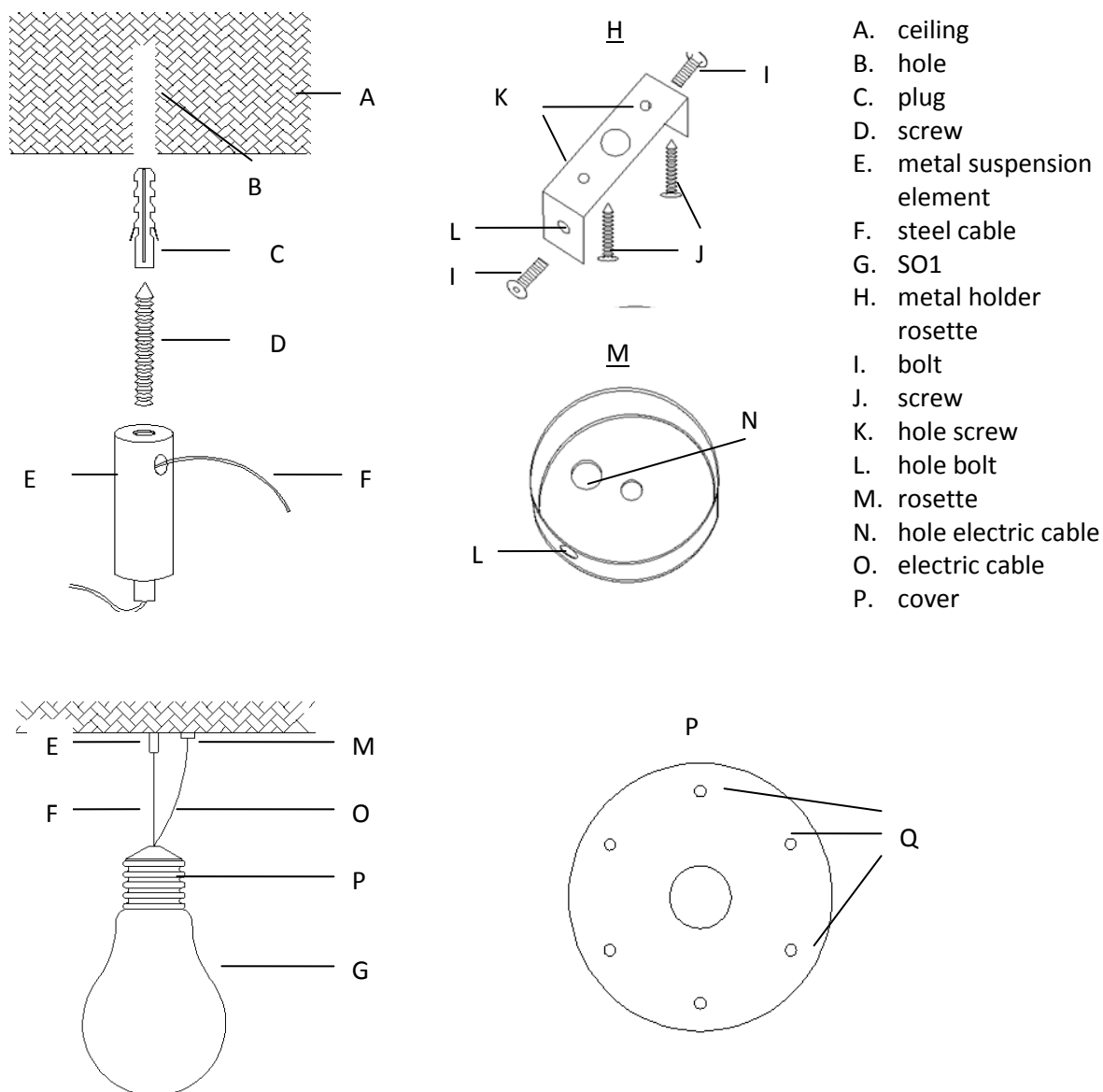
Version **RGB** DMX control

3. Installation

- ° Attach the plug to the ceiling
- ° Twist the supplied screw in the plugs
- ° Twist metal suspension elements (SE) in the screws
- ° Pull steel cable trough the little hole at the bottom of the SE. To pull back the steel cable; push the pin below and pull the steel cable at the same time
- ° Remove the metal holder from the rosette and screw into the ceiling
- ° Pull the electric cable trough the hole in the rosette and connect
- ° Re-attach rosette to holder



4. Replacing PL lamps

Remove the 6 bolts (Q) from the cover (P), take the cover of the SO1, and replace the PL dulux 55W by a new one.

5. Warranty

Eden Design's warranty obligations for this product are limited to the terms set forth below:

Eden Design warrants this Eden Design-branded product against defects in materials and workmanship under normal use for a period of TWO (2) YEAR from the date of retail purchase by the original end-user purchaser ("Warranty Period"). Eden Design may request that you replace defective parts with new or refurbished user-installable parts that Eden Design provides in fulfillment of its warranty obligation. A replacement product or part, including a user-installable part that has been installed in accordance with instructions provided by Eden Design, assumes the remaining warranty of the original product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes Eden Design's property. Parts provided by Eden Design in fulfillment of its warranty obligation must be used in products for which warranty service is claimed.
